RESOLUTION NO. 2023-08-R

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ST. HEDWIG, TEXAS AUTHORIZING A PRELIMINARY MAXIMUM AD VALOREM TAX RATE FOR FISCAL YEAR 2023-2024, AND SCHEDULING ANY REQUIRED PUBLIC HEARINGS; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, on <u>July 31. 2023</u> the City received the certified property tax rolls from the Bexar County Appraisal District; and

WHEREAS, the Bexar County Tax Assessor-Collector used this information and information provided from the City of St. Hedwig to calculate the No-New-Revenue and Voter-Approval tax rates for the 2023 Tax Year; and

WHEREAS, the 2023 Tax Year No-New-Revenue Tax Rate is \$ 0.502911 per \$100.00 valuation; and

WHEREAS, the Voter-Approval Tax Rate is \$ 0.556371 per \$100.00 valuation; and

WHEREAS, the City Council has determined that it is in the best interest of the City to establish a proposed maximum tax rate and to establish a preliminary date for the required Public Hearing; and

WHEREAS, Chapter 26.05(d) of the Texas Government Code states that a Public Hearing is required if the preliminary maximum tax rate exceeds the lower of the No-New-Revenue Tax Rate or the Voter-Approval Tax Rate; and

WHEREAS, if upon approval of the preliminary maximum tax rate for the 2023 Tax Year, the City Council will hold a Public Hearing, said hearing to be held on August 24, 2023

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. HEDWIG, TEXAS:
