

**RESOLUTION NO. 2211**

**A RESOLUTION CANVASSING THE RETURNS OF THE  
GENERAL ELECTION HELD ON THE 7<sup>TH</sup> DAY OF MAY, 2022,  
TO ELECT THE MAYOR AND TWO (2) COUNCIL MEMBERS  
FOR PLACES 2 AND 4 EACH FOR A TWO-YEAR TERM; AND  
DECLARING THE RESULTS OF SAID ELECTION.**

**WHEREAS**, on May 7, 2022, an election was held to elect the Mayor and two (2) council members to fill Places two (2) and four (4); and

**WHEREAS**, the City Council has investigated all matters pertaining to said election, including the ordering, giving notice, officers, holding and making returns of said election, all as required by applicable federal, state, and local law; and

**WHEREAS**, the election officers who held said election have duly made the returns of the result thereof, said returns have been duly delivered to the Council, and it is now necessary to declare the official results of the canvass;

**WHEREAS**, the City Council has diligently inquired into the poll lists and the official election returns which were duly and lawfully made to this City Council by the judges and clerks holding and conducting the election; the poll lists and the official election returns showing separately the votes cast in the election; and

**WHEREAS**, from these returns, this City Council hereby finds that the following votes were cast in the election by voters who were resident, qualified electors of the City:

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAINT HEDWIG, TEXAS:**

**SECTION 1.** The City Council having convened in a special city council meeting on this 18th day of May, 2022, to canvass the returns of the General Election held on May 7, 2022, and after canvassing the returns of this election, officially finds and determines that the election was duly ordered; proper notice of the election was given; proper election officers were duly appointed prior to this election; the election was duly held; the City has complied with the federal, state, and local law; and due returns of the result of this election have been made and delivered, all in accordance with the law and the Ordinance calling the election.




